1. **Call to Order**  
 Board President Nathan Ausley called the meeting to order at 5:31 p.m.
  
2. **Public Hearing on amendments to the Rules of the District as follows:**  
**Definitions I included in the Rules for the “Effective Date” of the Rules and for the addition of the definition of “Limited Production Wells”, provisions for the permitting, spacing, exceptions, and production of Limited Production Wells and the use of water from those wells, and amendments to the Rules in sections 7.5 and 14.1, 14.2, 14.3 and 14.8 including provisions for causing the Rules to be consistent with state law with regard to timelines for public notice and hearings requirements**  
 No comment was heard. The public Hearing was closed at 5:32 p.m.

**3. Public Comment**

Public comment was heard from Steve Box with The Environmental Stewardship concerning the denied wells applications in the Lost Pines GCD. Public comment was heard from Joe Cooper, General Manager for the Lost Pines GCD with regard to Mr. Box's comment, stating that 4 out of 7 permits were denied because they surpassed their current Management Plan.
