1. Public Comment

Called meeting to order at 10:15 a.m.

2. Welcome and Introductions

The meeting was chaired by Nathan Ausley, President of the Board of POSGCD. There was an introduction of all attendees. Their name and Districts were recognized.

3. Minutes of the April 27, 2005 GMA 12 meeting

Comment was made that Wayne Wilson of the Brazos Valley GCD was left off of the minutes as an attendee. The minutes will be corrected to reflect this change.

4. Report of GAM verification work, GAM runs and impacts across GMA 12, and statements of DFC's from GCD's in GMA 12

a. Mid East Texas GCD

There was no representative for Mid-East Texas present.

b. Brazos Valley GCD

Brazos Valley GCD passed the discussion to the hydrologist of Lost Pines GCD and Post Oak Savannah GCD

c. Post Oak Savannah GCD

Larry French, Hydrologist for POSGCD passed out updated figures for the Post Oak Savannah Groundwater Demand Projections.

d. Lost Pines GCD

Robert Kier discussed problems with the GAM and reported that all the problems had been corrected.

e. Fayette County GCD

No discussion was presented by Fayette County.

5. Scope of Work and process necessary to identify the Desired Future Condition of the aquifers in GMA12

Bob Kier encouraged discussion on how to verbalize the Desired Future Conditions for GMA 12. Larry French reported on Post Oak Savannah GCD's desired future conditions and their management zones. A review of the verbalization of the desired future conditions for each District were discussed.

The group discussed how the states' 6/10 rule would affect permitting and that GAM's could also be run using the 6/10 rule to determine future demands. It was decided that the hydrologist representing Brazos Valley GCD, Lost Pines GCD, and Post Oak Savannah GCD would meet and work together with the modelers from the Texas Water Development Board who are involved in modeling for Fayette County GCD and Mid-East Texas GCD, to continue to verify demands across the GMA and run GMA's using the updated demand numbers. They would also run GMA's using the 6/10 rule as demand numbers.

1. Report of GAM verification work, GAM runs and impacts across GMA 12, and statements of DFC's from GCD's in GMA 12
2. Scope of Work and process necessary to identify the Desired Future Condition of the aquifers in GMA12
