1. Welcome and Introductions

Called meeting to order at 10:08 a.m.

The meeting was chaired by Nathan Ausley, President of the Board of POSGCD. There was an introduction of all consultants of GCD's. Their name and affiliations were recognized.

2. Minutes of the August 28, 2008 GMA 12 meeting

The minutes of August 28, 2008 were approved as written.

3. Received Stakeholder Comment

Gary Westbrook, General Manager for Post Oak Savannah GCD gave a brief report on the results of the POSGCD stakeholder's meeting of September 3, 2008.

Public comment was heard from Dave Coleman of the City of College Station. A presentation was given by David Dunn with HDR Engineers concerning the Impact of large Groundwater withdrawals on the Economies of Brazos and Robertson Counties. Questions and comment were heard from the attendees. There were questions about this presentation from several attendees.

A presentation was heard from Dan Opdyke with the Texas Parks & Wildlife regarding the Desired Future Conditions with respect to impact on surface water flows.

John Burk, General Manager of Aqua Water in Bastrop County voiced concerns that were expressed in the Summary of Comments presented at the meeting.

Steve Box with the Environmental Stewardship gave a presentation and handout on Groundwater & Surface Water Crossroads with emphasis on environmental and clean water protection

Frank Limer, Russ Johnson. Mike Thornhill and Stacey Reeves representing End Ops, LP, expressed concern over landowner property rights and how DFC's adopted by the GMA 12 would affect those rights. Presentations and handout was given by Mike Thornhill. Russ Johnson also stated that he represented the Brazos Valley Water Alliance and his comments were the same for both parties. There were questions about this presentation from several attendees

Ridge Kaiser with Blue Water System LP, President of R.W. Hardin & Associates recommend that the GMA 12 revise the GAM Model and to look at mitigation and filed written comment with the GMA.

Laura Marbury with the Environmental Defense Fund gave a handout on the Texas Living Waters Project concerning sound management and planning for our water resources.

Ron Freeman and Paul Terrell with Blue Water Systems, LP presented comment for the protection of Landowner rights.

After brief discussion it was decided that final agenda items would be set at a later date.
