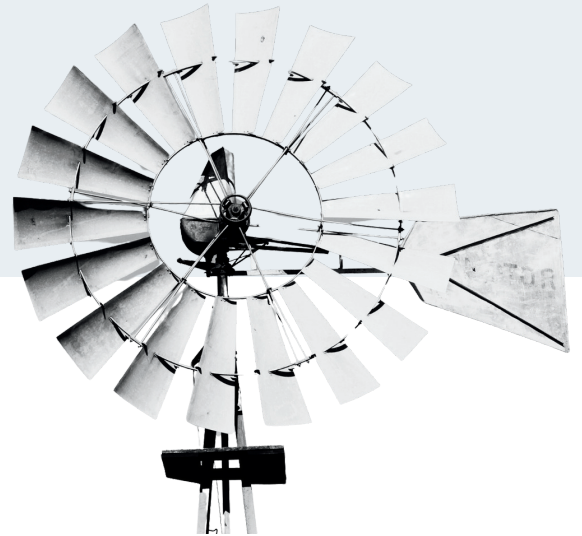
What a Year!

Year in Review



AQUIFER CONSERVANCY PROGRAM

Properties enrolled this year	214
Total number of acres protected	65,055 acres
Total amount paid to landowners	\$4.3 million



RAINWATER HARVESTING REBATES

Amount paid to harvesters this year	\$64,780
Total storage capacity added	72,040 gallons
Amount of groundwater pumping offset	94 acre-feet

DISTRICT WELLS

Number of new wells drilled this year	+ 128 wells
Number of new permits issued	+ 12 permits
Amount of new pumping permitted	6,638 acre-feet

WATER UTILITY GRANTS

Production Reports Due



Annual groundwater production reports for 2025 are due **February 15, 2026**.

Reporting is required for non-exempt wells and helps the district track aquifer conditions and meet state planning requirements.

Reports can be submitted online, or a form can be requested in person or by mail.

1 COMBINE

Grab an empty spray bottle and add 2 parts RUBBING ALCOHOL to 1 part WATER

2 SHAKE & SPRAY

Shake the solution and spray on to frozen windows and windshields. After about one-minute, the ice should break up and melt - no scraping necessary.

Free Well Water Testing Returns This February!



The District is launching its 2026 FREE Water Well Quality Testing Campaign, marking the first time the District has offered this program during the winter. Results will be distributed in person at a Texas Well Owner Network "Well Educated" workshop on March 3 at the Burleson County Expo Center.

This is a half-day training that covers groundwater, private wells, septic systems, and water quality, and helps well owners understand what their results mean.

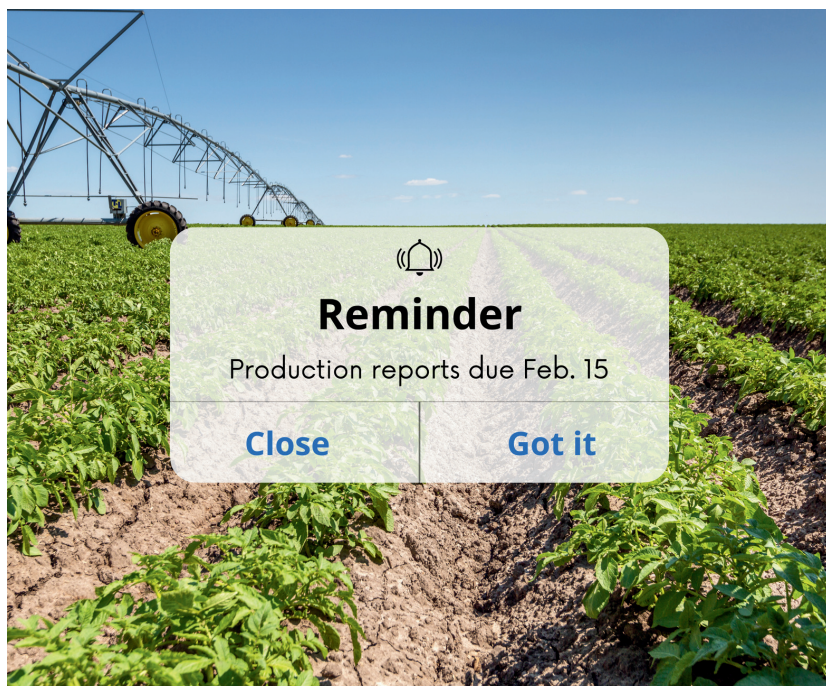
